2. Points of the agenda

a. Oxford Road – Open meeting (22nd Jan)

Need people to help set up on the day at 5pm. Starts at 5.30pm, should end at 7pm, free to ask any questions

Point of meeting – plans for library, what to do, how long it will take to get ready

Controversial topic of O Road – no decision will be made immediately but the Bursar will put forward his ideas for us to challenge or agree – important to have a united front

Huntingdon Road new site next to a graveyard, further away than O Road O Road currently is being held in trust for us

Best interests of the authorities aren't necessarily ours

Queries about the legal side – who gets to decide - we need to find this out Giving money made back into college, setting up a trust fund for the students

If we contest with a united front, they will hopefully reconsider or at least postpone

O Road – worth a huge amount of money – possible to build postgraduate and fellows housing on this land

Student welfare, bursaries created by the money

The money will be 'ours' but what control will we have

Vs. agricultural land of other plot

Emotional side of the argument – war memorial – huge focus

Can we be sure that they will be able to get planning permission for O Road

Will the new site be good enough for playing fields because it is agricultural land

Timescale – can't do anything to O Road until new site is finished

O Road will only be sold after new one is finished

Bursar wants to inform fellows of students' opinions

Open meeting will be first stage in us forming as a student body and deciding what line to take

Bursar will be coming at it from a pragmatic point of view, commitment to Fitz sport

How do we keep memorial but sell land? Half to 5/8 land will remain? Buildings will remain (house)

War memorial garden and keep tennis courts?

War memorial status transferred to the new site?

Was the original idea for the memorial dependant on the specific site or is it simply the existence of a sports ground?

No architectural plans so far

Talks of an Astroturf – there will be as many or even more buildings on the new site. New gym?

Securing planning permission for O Road site – Local residents may not be keen for it to be taken over by housing, let alone student housing.

What will the money available be used for if not used to buy the new land?

Idea of a poll? Perhaps after the meeting, i.e. once people are more informed

But will the poll be negative?

Current state of student housing needs to be reassessed – poor quality? Will the sale of O Road help this situation?

Will they go ahead if the students are behind them? The students are merely one of the parties who are relied upon for support. Alumni are also important.

Importance of upholding tradition – oldest thing that Fitz owns

How will the money be invested?

We would like a provisional itinerary/breakdown of what they'll use the money for – otherwise we don't know how to form an opinion on the issue How much money will they make, how much will we get, how will it be spent, how much input will we have?

Will improvements to student housing cause another rent rise?

Graduate housing – attractive?

How much will we benefit – this depends on the constitutional role of the JMA – should we be looking after undergraduates now or as a whole? Or both?

Will this be the best allocation of resources? Is this action necessary? In view of future improvements

Is there a way of testing the plan? Selling an acre? Not much point

Ideas of tradition vs. economics.

We are making a decision for the future.
